July 14, 2015

PTO 28(e) Stipend List

- On December 17, 2014, the Court issued an Order granting the Fee Committee's inspection costs and hold back motion pursuant to Pre-Trial Order No. 28(E).
- The Court approved a stipend of \$1,000.00 per KTP property and \$150.00 per non-KPT property.
- The stipend payment applies to eligible Chinese Drywall properties that are in the MDL Settlements.
- The stipend payments are to be paid to eligible attorneys from the Chinese Drywall Settlement Attorney Fee Fund, upon orders issued by the Court.

PTO 28(e) Stipend List

- The Settlement Administrator reviewed the Chinese Drywall Settlement Program databases and sent a Stipend List to each participating firm.
- The Stipend List shows all properties on file with the Chinese Drywall Settlement Program for a firm and an initial determination as to whether a property is eligible for a stipend payment, and if so, the amount of the stipend available for each property.
- Each firm must review its Stipend List carefully to confirm the accuracy of the information on the list.


PTO 28(e) Stipend List

- If a firm believes that its Stipend List is incorrect, the firm must notify the Settlement Administrator of the alleged discrepancy as follows:
 - If a property has been omitted from the list, add the property to the second tab of the Stipend List.
 - If the stipend amount is not correct, leave a detailed explanation in the column marked “Dispute”.
 - For all other discrepancies, please send a full explanation of the issue and provide any appropriate proof.
- Firms must send revised a Stipend List to CDWquestions@browngreer.com by Wednesday July 22, 2015.

Chinese Drywall Payment Summary As of 7/13/15


