TEMPERATURE IN THE MIDDLE OF SUMMER. I HAVE ALSO BEING IN

O.P.P FOR 19 MONTHS. IN A VERY DANGEROUS, HAZARDOUS, AND

VIOLENT AND DEADLY SURROUNDING. AMOUND RAPIST, MURDERES,

DRUG ADDICT, DRUG DEALERS, CHILD MOLESTERS, AND VIOLENT AND

CRAZY PEOPLE INCLUDING GANG BANGERS. AND MOST VIOLENT CRIMINALS.

I ALSO HAVE BEING ON HIGH BLOOD PRESSURE MEDICINE WITH MY PRESSURE

AT ¹⁸⁰/₈₅ FOR 19 MONTHS. WITH MY PRESSURE SO HIGH WERE I WAS

IN DANGER OF A HEART ATTACK OR STROKE AND ANERISM OF EVEN

KIDNEY FAILURE. MOST OF THE TIME THE AIR CONDITION WAS BROKEN

WITHOUT ALSO NO HEAT DURING WINTER ALSO THE SHOWERS BROKEN,

WITH RAT, ROACHES, AND NATS INFESTATION. ALSO SOMETIMES THE

I HAVE DONE SEVERAL PROGRAMS LIKE G.E.D. PRE RELEASE, COMPUTER, SUBSTANCE ABUSE
FOR WHICH THE GET FEDERAL CORANT MONEY AND THE HAVE NOT GIVING ME NO GOODTIME

38 INMATES HAVE DIED WHILE I WAS IN O.P.P
13 INMATES HAVE DIED HERE AT D.C.I IN 9 MONTHS.
INCLUDING MY FRIEND JESSIE WILLIAMS.
HE DIED JAN 20, 2013
I HAVE BEING MOVED AROUND 9 TIMES
THE PAROLE BOARD DENIED MY PAROLE THE HAVEN'T HONOR MY WRAP SHEET

DEPUTIES DISAPPEAR FOR MORE THAN 5 HOURS AT TIMES. IN A FIGHT

BROKE LOOSE DURING THESE TIME YOU COULD POSSIBLE DIE.

MANY OF TIME FIGHT BROKE LOOSE IN THESE BUILDING WITHOUT NO

AVAILABLE POLICE PRESENCE,

I ALWAYS HAVE TO BE HEAVELY MEDICATED. I SOMETIMES WAKE UP IN A

DEEP SWET I SUFFER FROM INSOMIA AND DIPRESSION.

I ALSO SPENT 15 MONTHS IN CONCHETTA PRISON. WITH VARIOUS PLUMBING

TRoubles AND HVAL TROUBLES.

I ALSO SPENT TWO WEEKS IN TENTH ONE. AND 3 MONTHS IN TENTH EIGHT

I ALSO SPENT 2 MONTHS IN THE NEW T.D.C BUILDING I HAVE

BEING TO HUNT FOR 6 WEEKS. I IN D.C.I FOR 9 MONTHS.

IF YOU WILL CONSIDER ME TO COME TO THE HEARING ON April 1, 20

AT 8:30 AM. I AM ALSO ORIGINALLY FROM HONDURAS CENTRAL AMERICA.

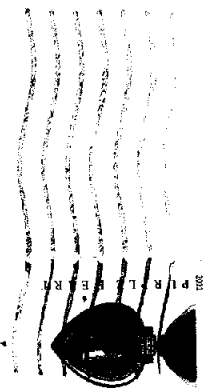
I AM AND AMERICAN CITIZEN I AM TRYING TO EXERCISE MY CONSTITUTIONAL

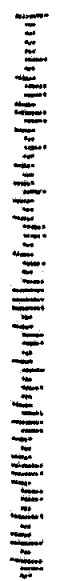

My name is (Nicholas D. Mirana Sr) a Inmate in Orleans Parish Jail (CTA) Pretrial Inmate I Have Been in Jail here since (Aug-26-11) and I'm a client of the Southern Poverty Law center and one of it's biggest supporters in this matter, I have been aboard this lawsuit since day one and I'd like to express some of my comments, thoughts, and concerns.

(First) I'd like to inform you that I am a inmate on a (Protective custody unit) due to my life being threatened by high ranking staff within Orleans Parish Jail, also in due to my life being threatened for speaking out and working with the Southern Poverty Law center and Justice Dept.

I have read a copy of the proposed settlement Decree, I've reread it at least X times, I do feel that the settlement fails and address's a lot of the inmates concerns, but what truthfully worries me is the (Sheriff, his office and his staff within the Jail) I do believe (MR. Gusman) is untruthful and will not hold up to his end of the deal, I think there is a need

For a special (monitor) TOPE on hand at all times within the Jail For at least 6 months to make sure the Sheriff and his staff abide by the Settlement Decree

I will tell you, from my first hand experience that this Jail to this date is still a very dangerous place, with a lot of understaffing, contraband, fights, jumping, stabbing still taking place. I was on the medical unit (D-2 OPP) old Jail from Aug-26-11 till July-21-12 and witnessed first hand dozens of stabbings, and serious injuries from inmate on inmate assaults and staff on inmate assaults, still till this day these assaults are still taking place and not being reported by the Sheriff and his office..... the Grievance Process is still a threat to inmates lives, because of the lack of confidentiality, they have a grievance person who picks your grievances up and gives out blank grievances but when they are returned with your reply, a regular unit guard pass's them out, calling the inmates who he gives them two (rats) also certain guards have told other inmates on the unit (who) filed grievances and for what. There have been no real changes since the lawsuit was filed and a Decree signed..... (yes) they have cleaned up the Jail (a little) but that was only for (show and tell) once S.P.L.C and the Justice Dept. leave it's back too.

the same old Jail, I cannot express my concern enough, I am no angel and have been to prisons from (Cal) to (L.A) and the (Feds) and I have never seen a Jail run like this place and the danger of it... you are never safe in this Jail whether on (Protective Custody) the Hole or any place

I only pray for the courts, to place a (monitor) within the Jail... because the Sheriff can not be trusted with this job) I can tell you first hand, the things that still go on now, on (P.C) from everyday living to a failed grievance system, to guards sleeping on the job, from cellphones, drugs on the units, to a Bed jumping that just took place on 12-13-12 on (CTA-2T)

I would like to say I do believe in change and I do believe in (S.P.L.C) and there work and support, I also believe in the Justice Dept. I know changes don't come fast and things take time but we all know how this system has been run for 20 years, the Hole system in L.A is broken (Justice system) penal system) and from my own point of view I no

you must pay for your (wrong actions) But no one should have to serve there time or await trial in this type of conditions or in fear, or played upon cause your weaker then others and the system is suppose to Relabillatate people not Harm them and as for (young teens) under (17) I personally lived with them ages (14, 15, 16) in a mixed (P.C) dorm setting in (CJA) - 2T around July - Aug - Sept - 2012, my own son was in OPP at 16 and subjected to contact and abuse by adult inmates (He now is in D.C.I state prison youth program) so I do know the Harm of a broken system, (I Half to Face myself everyday in the mirror) and maybe for life within these type of settings, I only pray my son and no other teen or person has to suffer as I have in OPP. So in saying all this my (comment) is (yes) I think the settlement is (good) But do I Beleave the sheriff, the Parish, the Jail will abide by it (No) I dont I think this system needs a (monitor) with in the Jail and the Justice and Feds over sight. with that, then maybe theres a chance for change (Thank you)

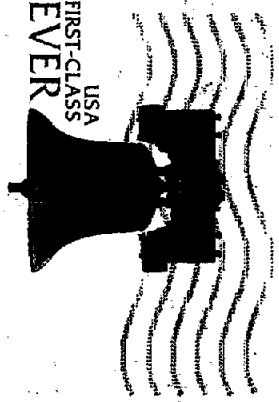
