MINUTE ENTRY

The Court held a discovery conference in these consolidated proceedings on Thursday, October 25, 2012. At the conference, the Court set the following schedule:

1. By **Friday, November 16, 2012**, the parties shall submit a joint statement memorializing each party's discovery obligations in accordance with the Court's orders from today's conference.
2. By **Monday, December 3, 2012**, the parties shall submit a proposed case management order including: 1) interim deadlines and procedures for document production with a completion date no later than June 1, 2013, 2) a plan for third party discovery, 3) a schedule for conducting depositions that can be completed before June 1, 2013, and

- 4) a proposed schedule for conducting remaining nonexpert depositions, exchange of expert reports, and expert depositions. If there are areas of disagreement, the parties shall concisely state their positions on the disputed matters.
3. The Oral Argument on the Motions to Dismiss scheduled for Wednesday, October 31, 2012, is rescheduled for **Thursday, December 6, 2012 at 10:00 a.m.** The plaintiffs will have a total of one hour and the defendants will have a total of one hour for oral argument. Immediately following the hearing, the Court will hold a status conference to discuss issues raised by the proposed case management order.
