REPLACEMENT ON PSC AND EXECUTIVE COMMITTEE

Hollis L. Salzman, a member of both the Plaintiffs' Steering Committee and the Executive Committee for the Direct Purchaser Plaintiffs in this litigation, has resigned from this case and is no longer with the law firm Labaton Sucharow, LLP.
