Global, Banner, InEx Repair and Relocation Frequently Asked Questions

1. Where will the Settlement Administrator send checks?

The Settlement Administrator will send checks to attorneys for represented claimants. Checks will be made out to the claimant only.

2. Why did I receive multiple checks for one claimant?

The Settlement Administrator must issue checks separately from each Chinese Drywall Settlement Fund. This means that the Settlement Administrator may issue two separate checks for a single claim.

3. Does this payment cover Other Loss claims?

No. The Settlement Administrator is only issuing checks for Global, Banner, InEx Repair and Relocation claims. Claimants who are eligible for compensation for Other Loss claims will receive separate payment.

4. Why haven't I received payment yet?

Claimants must submit a completed W-9 Form and a Verification of Claims Form to receive payment. Both forms are available on the Chinese Drywall Portal at <https://www3.browngreer.com/Drywall/Un-Secure/PaperForms.aspx>.
