IT IS ORDERED that:

- (1) A one-week jury trial is hereby set for <u>March 2, 2015</u> at <u>8:30 a.m.</u>;
- (2) A Final Pretrial Conference shall be held <u>February 12, 2015</u> at <u>9:00</u> <u>a.m.</u>;
- (3) Counsel shall submit by <u>May 9, 2014</u>, a proposed scheduling order setting forth pretrial deadlines;

- (4) The PSC shall designate by <u>May 16, 2014</u>, which plaintiffs claims shall be tried on March 2, 2015;
- (5) Cincinnati Insurance Co. and Franck's Pharmacy, Inc. shall participate with the PSC in a settlement conference before United States Magistrate Judge Karen Wells Roby on <u>June 9, 2014</u>, at <u>1:30 p.m.</u>, or such other time as ordered by Magistrate Judge Roby;
- (6) Amended complaints by Louisiana plaintiffs adding a direct action claim pursuant to a policy covering the professional liability of James Kilbride shall be filed not later than <u>June 10, 2014</u>, at <u>9:00 a.m.</u>, and may be filed without seeking further leave of Court;
- The PSC and counsel for Cincinnati Insurance Co. and Franck's
 Pharmacy, Inc., shall submit a joint confidential settlement status report to
 Magistrate Judge Roby by <u>July 7, 2014</u>; and
- (8) The Court will hold a status conference in chambers with liaison counsel and committee members on <u>Friday, June 13, 2014</u>, at <u>11:00 a.m.</u>.
 Out of town members of the PSC may participate by telephone.
