This court issued an order to Maurice R. Franks to show cause why he should not be removed from this court's bar based on the Supreme Court of Colorado's May 14, 1990 order of disbarment. Franks responded stating that removal by this court was unwarranted, and requesting a hearing. Among other arguments, Franks recited that he is disabled and already "retired from . . . law practice." Later, he filed a "Motion for Disability Inactive Status and Hearing," in which he requested "that he be placed on disability inactive status (suspended for reasons of disability)."

This court does not maintain a bar membership category entitled "disability inactive status." When an attorney in another jurisdiction is placed in such status, this court's practice is to suspend the attorney, and direct that if and when the attorney resumes active bar membership, he may petition this court for reinstatement. The court accepts Franks's representation that he is currently disabled and unable to practice law.

Accordingly, Franks's "Motion for Disability Inactive Status and Hearing" is GRANTED IN PART, and Maurice Franks is SUSPENDED as a member of this court's bar until such time, if any, that he petitions for
