
**JOINT NOTICE EXTENDING TIME PERIOD  
FOR ENROLLMENT AND TO FILE CLAIM FORMS**

Defendants' Liaison Counsel and Plaintiffs' Liaison Counsel (collectively the "Parties") hereby provide notice that they have extended the time-period for enrollment in the MDL Settlement Program ("the "Program") and that they have agreed to extend the time-period for the filing of claim forms as follows:

- (1) On April 13, 2005, the Parties published in a joint statement advising that minimum enrollment levels in the Program had been reached, triggering the six-month timeframe for enrollment in the Program to remain open. Enrollment was originally scheduled to remain open until October 13, 2005.
- (2) Due to recent events, the Parties have extended the timeframe for enrollment from October 13, 2005 to December 15, 2005.
- (3) Under the paragraph 7 of the Term Sheet, an Enrollee shall have 120 days from the date of minimum enrollment (April 13, 2005) or from the date the enrollee serves an Enrollment Form, whichever is later, to serve a Claim Form.


- (4) On July 18, 2005, the Parties filed a Joint Notice Extending Time Period to File Claim Forms, extending the time to serve Claim Forms by 60 days. For those Enrollees who served Enrollment Forms on or before April 13, 2005, the time-period for them to serve Claim Forms was extended from August 11, 2005, to October 10, 2005. For those Enrollees who served Enrollment Forms after April 13, 2005, the time period for them to serve Claim Forms was extended 120 days from the date of service of the Enrollment Form, or October 10, 2005, whichever would have been later.
- (5) For those Enrollees who served Enrollment Forms on or before April 13, 2005, the time period for them to serve Claim Forms is further extended from October 10, 2005 to December 15, 2005.
- (6) For those Enrollees who served Enrollment Forms after April 13, 2005, the time period for them to serve Claim Forms is further extended to either 120 days from the date of service of the Enrollment Forms or to December 15, 2005, whichever is later.
