A Monthly Status Conference was held on this date by telephone in the Chambers of Judge Eldon E. Fallon. At the conference, counsel reported to the Court on the topics set forth in Joint Report No. 90 of Plaintiffs' Liaison Counsel (PLC) and Defendants' Liaison Counsel (DLC). This conference was transcribed by Ms. Arlene Movahed, Official Court Reporter. Counsel may contact Ms. Mohaved at (504) 589-7777 to request a copy of the transcript. A summary of the Monthly Status Conference follows.

I. MDL Resolution Programs I and II

MDL Resolution Programs I and II are nearing an end. All qualified tiered claims have been submitted to the Medical Panel in both programs. The Special Master's Office is finalizing the clearance of any remaining administrative claims in both programs.

As to Propulsid I, the Special Master has submitted 4,245 Tier I, II and III claims to the Medical Panel for Review. Of the 4,245 claims, Defendants have treated 3,528 on an expedited basis. Thirty-two (32) of the tiered claims submitted to the Panel have been found eligible by the

Panel, and the Special Master has made those awards. (All numbers are current through April 19, 2011.)

As to Propulsid II, 381 claims have been submitted to the Medical Panel for review, of which Defendants have treated 326 on an expedited basis. (These numbers are current through April 19, 2011.) Three (3) claims have been found eligible.

II. Distribution of MDL Settlement Funds

On November 30, 2009, the Court issued an Order granting Joint Motion for an Order authorizing Distribution of MDL I Settlement Funds which authorized the transfer of 8.75 million (Canadian) from the Settlement Fund of the MDL I Propulsid Resolution Program Fund to the Propulsid Resolution Program and further authorized a distribution in the same amount for appropriate contributions to charitable organizations (the Order was amended on December 3, 2009). On January 4, 2010, the Court issued an Order appointing a committee of plaintiffs' counsel and defense counsel to assist in recommending to the Court where the remainder of the funds should be allocated (Rec. Doc. 4023).

III. Attorney's Fees Issues

On December 1, 2010 the Court issued an Order (Rec. Doc. 4155) approving the distribution of funds to pay expenses. In addition, the PSC will be filing a motion, and the Court will address the attorney's fees issue at a later date.

IV. Amended Motion for Order Dismissing with Prejudice Claims of Plaintiffs who Failed to Enroll in the MDL Resolution Program and Motions to Dismiss

On April 13, 2011, Defendants filed an Amended Motion for Order Dismissing with Prejudice the Claims of Plaintiffs who Failed to Enroll in the MDL Resolution Program (Rec.

Doc. 4326). All affected parties were served through their counsel of record via the Court's CM/ECF system, U.S. Mail (certified, return receipt requested) and Lexis/Nexis. The Motion has also been uploaded to the Court's website. The hearing for this Motion is set for June 16, 2011 at 9:00 a.m.

Defendants are working with the Special Master's Office to obtain reports listing:

plaintiffs who have qualified and been paid for the administrative fee; plaintiffs who did not

qualify for the administrative fee; and plaintiffs who failed to submit medical records. Following

receipt of these reports, Defendants will prepare omnibus Motions to Dismiss as to these groups.

V. Motion Seeking Relief from Pre-Trial Order No. 2, Authorizing the Destruction,

Disposition or Return of Records Pertaining to Propulsid I & II and Closing Plaintiffs'

Depository

On April 18, 2011, the PLC filed a Motion Seeking Relief from Pre-Trial Order No. 2, Authorizing the Destruction, Disposition or Return of Records Pertaining to Propulsid I & II and Closing Plaintiffs' Depository. The hearing for this Motion is set for May 11, 2011 at 9:00 a.m.

VI. Current Propulsid II Timeline Status Report

- 1. Claim Forms were due on 12/1/07. The Special Master's Office has received 1,724 claim forms.
- 2. Medical Records were due on 1/30/08. To date, approximately 97 % of the claimants who have submitted claim forms have submitted medical records.
- 3. Claimant memorandums were due on 3/30/08. To date, the Special Master's Office has received 9% of these on Tier claims.
 - 4. Administrative claims began being processed on 4/1/08. To date, 436 of these

claims have been paid and proceeds forwarded to claimants.

5. The Special Master's Office began clearing claims for defense briefing on 5/31/08.

All qualified tier claims with medical records have been cleared for defense briefing.

6. The Special Master's Office began receiving defense memorandum on August 22,

2008.

7. Expedited claims began going to medical panels on August 28, 2008.

Disbursements began on December 23, 2008 regarding administrative payments on any of these

claims which were declared ineligible. The most recent batch was disbursed on February 11,

2011. It is anticipated that the next batch will be released to the defense for approval for payment

on April 21, 2011.

Non-expedited claims began going to medical panels on September 27, 2008 and

administrative payments on any of these claims which were declared ineligible began on

December 23, 2008. The most recent batch was disbursed on February 11, 2011. It is anticipated

that the next batch will be released to the defense for approval for payment on April 21, 2011.

9. Payment of claims which are declared eligible will begin as soon as they are cleared

by the panel and the required documentation has been submitted. Payment of eligible claims

have been disbursed.

Ineligible: 377 (of that, 326 are expedited)
